## Mayor's Message

### MAYOR PETER E. DONOGHUE BATTLE FOR BOROUGH'S CHARACTER ISN'T OVER

Fortunately, we have the state's foremost COAH attorney, Jeffrey Surenian, representing us.

K Hovnanian has options to buy both properties and, right now, we can expect another series of hearings on its Giuliani application before the Planning Board.

In any case, with the McConnell application now out of the picture and talks over the Giuliani property likely, soon we will be able to focus on actual acquisition. Although it wouldn't be prudent to telegraph our strategy, we have already established the fair market value of each property and are prepared for serious negotiations.

The withdrawal by Hovnanian is "a triumph for common sense in light of the expressed wishes of the people and this administration. Just as important, this is a major step toward acquiring the property for public use."

All who have participated in the battle over the McConnell property should be very proud. Particularly praiseworthy are the members of the "Waterfront for Everyone" citizens group, Borough Administrator Adam Hubeny, Councilwoman Stephanie Ladiana and Mr. Surenian, who apparently contributed to KHov's decision by making it clear how hard it would be for them to win.

Much of Atlantic Highlands has come together to fight the good fight. We can't let up now!

No matter how each of us feels on the subject, the battle over whether we'll have condos or public space on our waterfront isn't over yet.

Clearly, my position is known: I oppose high-density condominium villages and favor public use of our last significant bay front land. And I think the vast majority of borough residents feel the same way. So, I am absolutely thrilled that K. Hovnanian Shore Acquisitions has withdrawn its application to construct 42 condominium units on the McConnell tract.

Although we do not know what plans, if any, Khov may now have for the McConnell property, we do know that the company says it will pursue its effort to build 80 condo units on the Giuliani property. This proposal is opposed even more strongly by local citizens, including over 1,000 residents who recently petitioned the Mayor and Council to acquire the land by condemnation, if necessary.

Assuming our adversaries proceed with the quest to build on the Giuliani property, it will take a lot of energy, vigilance and money to thwart them.

And, of course, we are still vulnerable to the efforts of developers right up until the time the state Council on Affordable Housing certifies our bi-partisan plan for Mount Laurel housing, a plan that

does not include condos on the waterfront, be they market or affordable units.

For the record, Atlantic Highlands is committed to building affordable housing. And Atlantic Highlands will fulfill its obligations, despite what K Hovnanian tells COAH, by building affordable units on Leonard and Simpson Avenues and by farming out several units to Lakewood as provided for by law.

We don't need KHov to come in on a white charger to help us provide low- and moderate-income housing. Now we must convince COAH.

Of course, the actual acquisition of the McConnell and Giuliani tracts will be a considerable challenge, too. Although the road ahead may be bumpy, your Mayor and Council are determined to continue the effort to maintain the character of our borough and preserve and improve the two properties as a legacy for our children.

As most of you know, the borough has been assured considerable funding from Green Acres and other agencies to acquire both.

But the first thing we must accomplish is to get COAH to lift the restraint it placed on us moving to acquire the McConnell property. And we must also convince that agency not to restrain us from buying or condemning the Giuliani property.

# Community Development Awards Borough \$139,126

The Community Development Block Grant Program [CDBG] has awarded the Borough a \$139,126.00 grant for the rehabilitation of roads in the Community Development service area located on the east side of town. The roads that were submitted for rehabilitation, in the grant application prepared by T&M Associates include East Avenue, from Highway 36 to Wesley Ave; Simpson Avenue from East Avenue to the eastern terminus and Wesley Avenue from East Avenue to the eastern terminus.

The CBDG group, made up from representatives from different Municipalities in Monmouth County, voted the Atlantic Highlands project for FY2007, number 5 out of 12 municipal projects that were submitted, as reported by Borough Administrator Adam Hubeny, who also serves as the CDBG coordinator for Atlantic Highlands. The amount we submitted for was \$160,942.00. The group awarded the Borough \$139,126.00 which is \$ 21,816.00

shy of what we asked for. Not too bad when the fact is some municipalities were not funded at all. No one town or group received 100% funding. In short, CDBG funded approximately 87% of this proposed project. That's real good news.

The project will involve rehabilitating the existing roadbed of East Avenue from Route 36 to Wesley Avenue by way of base repairs as necessary and then milling and overlaying the entire roadway width. As one of the main roadways within the CDBG eligible area, the rehabilitation of East Avenue will greatly benefit residents in this area of the Borough. Rehabilitating the existing roadbed as well as roadway regrading will alleviate flooding in those areas. New curbing will be installed on both sides of the roadway as the current curbing is deteriorated and virtually non-existent in areas as well as replacing driveway aprons and sidewalk in low lying areas.


The Simpson Avenue portion of the project will include base repairs

as necessary and then milling and overlaying the entire roadway from East Avenue to the eastern end. In addition, a portion of a road drain at the end of Simpson Avenue will be replaced with ADS piping as it is deteriorated and in need of replacement. Additionally, the project will also include replacing the handicap ramps at the Simpson Avenue intersection to bring them into compliance with current ADA standards.

The Wesley portion of the project will include base repairs as necessary and then milling and overlaying the entire roadway from East Avenue to the eastern end where it meets a condominium association driveway. By adding the portions of Simpson Avenue and Wesley Avenue east of East Avenue, this portion of the eligible area will see a great improvement to the public roadways which will improve current property values which will inherently affect residents in a positive way.

# Election Day is November 7th

Participating in the democratic process by voting, is not only a precious right, it is a civic responsibility. For while we live in a free society, that society still operates on the basis of laws. Only by voting can we have a voice in determining who makes those laws.

On a daily basis, public safety, health care, equal justice, the cost of goods and services and other issues that help determine our quality of life, are influenced by the decisions our elected leaders make. If we do not vote, we allow others to choose those leaders. And, ultimately, we relinquish a vital opportunity – the opportunity to help shape the policies that will guide our future.

### You can vote if you are:

- A U.S. citizen.
- At least 18 years of age by Election Day.
- A New Jersey resident at least 30 days before the election.
- Not in jail, on probation or parole because of a felony conviction.
- Registered to vote at least 21 days before the election.

Your Voter Registration Application must go to your County Commissioner of Registration. It is postage paid so it does not

cost anything to mail it. You can also drop it off at the Commissioner's office or your Municipal Clerk's Office. **It must be received by a voter registration agency by the 21st day before the election [October 17, 2006]. "No Excuses" Anyone Can Vote by Mail It is now the law that any voter can vote by absentee ballot for any election, no reason required.** To get an absentee ballot, you must fill out an application. You can get an absentee ballot application from the Municipal Clerk's office. Or you can also visit [www.NJElections.org](http://www.NJElections.org) to download an application.

If you are permanently disabled, you can ask for an absentee ballot for all the elections in a calendar year on one application. **Any voter who wishes to vote only by absentee ballot for a general election can request to receive automatically an application for general elections.**

If you are a United States citizen, at least 18 years of age, and are registered to vote in accordance with New Jersey law, you have the legal right to vote. I urge you to exercise that right.

There is an increasing need for people to work at the various election districts in your town and surrounding communities for the General, Primary and School or Municipal Elections. If you are a registered voter and would like to earn extra money, as well as participate in the Election process, we would like to hear from you. The present compensation for working an election is \$200.00. Under statute 39:4-36 of the New Jersey Motor Vehicle laws it states the driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within a marked crosswalk or within any unmarked crosswalk at an intersection, except at crosswalks when the movement of traffic is being regulated by police officers or traffic control signals. NO pedestrian shall suddenly leave a curb or other place of safety and walk or run into the path of a vehicle which is so close that it is impossible for the driver to yield. Nothing contained herein shall relieve a pedestrian from using due care for his or her safety.


Whenever any vehicle is stopped to permit a pedestrian to

cross the roadway, the driver of any other vehicle approaching from the rear shall not overtake and pass such stopped vehicle.

**Every pedestrian upon a roadway at any point other than within a marked crosswalk or within an unmarked crosswalk at an intersection shall yield the right-of-way to all vehicles upon the roadway.**

*Nothing contained herein shall relieve a driver from the duty to exercise due care for the safety of any pedestrian upon a roadway.*

I hope this clears up confusion concerning pedestrians crossing the street.

## Atlantic Highlands First Aid to Hold Open House

Area residents will get a chance to meet their local EMS volunteers Nov. 4 when the Atlantic Highlands First Aid Squad holds an open house.

From 10 a.m. to 2 p.m., residents can see the squad's inventory of emergency service vehicles and boats, and meet some of the men and women who give up some of their free time to help their fellow neighbors.

"The open house is a terrific way for people to get a sense of the Atlantic Highlands First Aid Squad in a non-emergency situation," said Captain Jerry Pandolfo. "We'll have members on hand who are happy to explain what we do, and it's a family friendly event so children are welcome to get a close-up look at the ambulances."

The open house comes after a busy and productive summer for the all-volunteer EMS organization. By mid August the squad had responded to more than 300 calls for help, including a handful in the harbor. Several times the squad deployed the Marine Rescue Unit, which includes rescue boats from the First Aid Squad and the Atlantic Highlands Fire Department.

"We have trained extensively for water rescues, and already the team has been put to the test," Pandolfo said, noting the rescue of a man whose boat capsized earlier in the summer as well as the team's response to a yacht fire off of Sandy Hook. "We're also well trained to deal with cold-water rescues in the winter months."

The squad also invested in an upgrade of its vehicle extrication equipment and training this summer, giving members increased flexibility and skills in removing patients who may be trapped in car wrecks or, perhaps, under boats in the harbor.

"Thanks to the generosity of our neighbors, we've gotten several used vehicles that we cut up to simulate trapped victims," Pandolfo said. "And, we're always open to more vehicle donations."

The more times we practice, the better we'll be. If you've got a spare car, call us."

Ultimately, Pandolfo noted, he hopes the open house may lead to a

few new members. Like every other volunteer organization in the state, the Atlantic Highlands First Aid Squad is always looking to build its membership and increase the number of men and women responding to calls for help.

"New members bring new ideas and energy to the organization," Pandolfo said. "We've got a great team now, but we can always grow and get better. No experience is necessary. Training is provided for free. The commitment is small, but the rewards of helping others are immeasurable."

Besides adult members, the squad also has a Cadet program for anyone between the ages of 14 and 18. Cadets learn first aid and CPR. And, once they're 16 years old they can respond on the ambulance to certain types of calls.

"The Cadet Program is a great way for young folks to get involved with the first aid squad," Pandolfo said. "Many of our current adult members came up through the program."

The Atlantic Highlands First Aid Squad provides free, around-the-clock emergency medical services to Atlantic Highlands residents and to the surrounding area. It operates on donations from the community and is staffed by volunteers who used their time to train to help others.

"We hope that through this open house, residents will be able to see we're more than just sirens and flashing lights," Pandolfo said.


# Streetscape Update

The Borough has accomplished a great deal in the last number of years in improving its infrastructure and beautification along First Avenue, and would like to continue those efforts. T&M Associates, on behalf of Atlantic Highlands has submitted a Centers of Place application for the Transportation Trust Fund Fiscal 2007 State Aid Program, in an effort to obtain additional funding to continue the Streetscape project from Lincoln Avenue to Highway 36.

The New Jersey Planning Commission has designated Atlantic Highlands Center as a "Town Center"; therefore the Borough of Atlantic Highlands is an eligible applicant for the Centers of Place Funding Program. The

Borough had received two prior grants associated with the 'Centers of Place' Funding Program. In fiscal year 2002, \$250,000 in funding was utilized for the streetscape project along First Avenue from Bay Avenue to Mount Avenue. This year we received an additional \$300,000, which extended the project along First Avenue, between Mount and Washington Avenues. The pavers for this project have been laid and the benches, lighting, and trash receptacles are currently on order and will be installed.

We are asking the State to contribute \$442,824.00 to continue the third and final phase, that would replace broken, uneven sidewalks and deteriorating curb with new, concrete



pavers sidewalks, along with new concrete aprons, handicap ramps and curbing.

Highway 36 and First Avenue is the primary entrance into Atlantic Highlands. First Avenue is the Main Street and "heart" of Atlantic Highlands and provide access to the Marina and the Veterans Memorial Park, it also provides direct frontage for multiple retail shops and stores.

## EAGLE AT THE SPRING



The trail and water structures in the small park at Henry Hudson Springs were improved recently in a project organized by Eagle Scout candidate William C. Kelly from Atlantic Highlands Troop 97.

Kelly and his crew cleared a new, safer route for the trail below the springs that leads to Sandy Hook Bay. The previous trail was right at the eroding edge of the drainage channel. The scouts also installed sever-

al water bars along the new trail to prevent erosion of the path. The improved route will give better access to and from the future hiking and biking trail along the Bayshore.

At the springs, the broken basin and spillway that channel water coming from pipes in the wall were rebuilt and relined to contain water flows.

Also, a support column for the stonewall that houses the spring's pipes was rebuilt.
