ORDINANCE 16-2011

AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF ATLANTIC HIGHLANDS, CHAPTER 139 THEREOF, ENTITLED VEHICLES AND TRAFFIC

BE IT ORDAINED by the Governing Body of the Borough of Atlantic Highlands, in the County of Monmouth and State of New Jersey that Chapter 139 entitled Vehicles and Traffic, of the Code of the Borough of Atlantic Highlands is hereby amended with the addition of the following:

SECTION I

Article V § 5-2 - Stop Intersections Designated:

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections and shall be included in Schedule VIII, attached to and made a part of this chapter, and STOP signs shall be installed on the streets as provided therein:

Intersection Stop Sign On:

East Mount Avenue and Prospect Circle - sign located on East Mount Avenue for west bound traffic.

SECTION II

Article II § 2-2 – Parking Prohibited at all times

The Code of the Borough of Atlantic Highlands, Chapter 139, Vehicles and Traffic, Article II § 2-2 is amended by including the following addition:

No person shall park a vehicle at any time upon any of the streets or parts thereof described below and these streets shall be included in Schedule I attached to and made a part of this chapter:

Name of Street	Sides	Location
Cameron Circle	North Side	From a point starting at the easterly curb line of Bonnie Brae Path to a point ending at the westerly curb line of Hilton Road

SECTION III

Article II § 2-3.1 – Parking Regulations for Municipal Parking Lot and Other Areas

The Code of the Borough of Atlantic Highlands, Chapter 139, Vehicles and Traffic, Article II § 2-3.1 is amended by including the following addition:

G. Municipal Harbor Tennis Court Lot – West Side – The seven parking spaces adjacent to the Harbor Parking and Municipal Gazebo between the hours of 8:00pm.

SECTION IV

<u>Violations and Penalties</u> - Unless another penalty is expressly provided by New Jersey statute, every person convicted of a violation of a provision of this chapter or any supplement thereto shall be liable to a penalty of not less than \$10 nor more than \$50 or imprisonment for a term not exceeding 15 days, or both

<u>Signage</u> - All signs, posts, pavement markings or other necessary materials shall be installed as necessary and shall conform to the current regulations for Uniform Traffic Control Devices.

<u>Severability</u> - Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

SECTION V

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION VI

This ordinance shall take effect immediately upon adoption and publication according to law.
