Atlantic Highlands Celebrates 125 Years

Atlantic Highlands was incorporated as a borough by an Act of the New Jersey Legislature on February 28, 1887, from portions of Middletown Township, containing 1.2 square miles of land bordering on the Raritan Bay.

The town overlooks where the Atlantic Ocean and Raritan Bay meet at Sandy Hook, and its hills mark the highest point on the eastern seaboard of the U.S., south of Maine.

For thousands of years, the original inhabitants were the Lenape, who lived in and along the cliffs and creeks of Atlantic Highlands. The Lenape traded with the Europeans and sold a group of English settlers an area that covered the entire peninsula that was named Portland Poynt, making them the first European residents of present day Atlantic Highlands.

During the late 1800s, there was an onrush of resort developers, church groups and town builders. They created the Victorian core of the town, attracting thousands of visitors and year-round residents.

In 1879, a surveyor was engaged to lay roads and lots for a permanent community. The Atlantic Highlands Association was formed by prominent members of the Methodist Church. This organization developed the community of Atlantic Highlands.

Individuals and groups came from



New York City and the surrounding vicinity to camp along the water in tent colonies. An outdoor amphitheater was created with a large seating capacity and outstanding acoustics. An indoor auditorium was built, which was utilized for entertaining visitors at the camp meetings.

The next twenty years saw rapid development within the community. Major construction occurred during the 1880s through 1900. It included hotels, cottages, rooming houses, and private homes. A pier was built which extended well into the bay to accommodate steamboats from New York City. A water and sewer system was constructed, and the road system was completed. During this period of development a fire department was organized.

A number of local churches also saw their beginning in the 1880s: the Central Baptist, First Presbyterian, Saint Agnes Roman Catholic, First Methodist, and Saint Paul Baptist Church.

Today, from its hills and bayside, the Manhattan skyline can be seen. Out from its harbor, which is the largest on

the East Coast, sail pleasure, fishing and commuter boats. The rail route formerly used by, the Central Railroad of New Jersey is now used by the Henry Hudson Trail and names that appear in the directories of the 1800s are the same names that populate the borough and run businesses in the community today.

VOTER REGISTRATION

If you are eligible to vote in New Jersey, you may register to vote at any Municipal Borough Hall, any MVC Agency while applying for/renewing a license or non-driver identification card, or by going to www.NJELECTIONS.org

if you need a Voter Registration form.

The Voter Registration deadline is October 16, 2012 [21 days before an election]. To see if and where you are registered to vote, go to www.NJELECTIONS.org.

UPDATE YOUR VOTING ADDRESS

If you have not already reported a change of address to the NJ Division of Elections, you must mail a new Voter Registration form directly to the NJ Division of Elections, PO Box 304, Trenton, NJ 08625-9983.

VOTE BY MAIL

In New Jersey, any voter can now vote by mail in any election. You no longer need a reason to vote by mail. Have to work and won't be home in time? Will you be out of town? Simply vote by mail. Now there is "no excuse" not to vote!

To receive your ballot by mail, the County Clerk [not Borough Hall] must receive a Mail-In-Ballot application 7 days prior to the election. You may also apply in person to the County Clerk [not Borough Hall] until 3:00pm the day before the election. Applications can be picked up at Borough Hall or downloaded from www.njelections.org, and sent to the Monmouth County Clerk, 300 Halls Mill Road, Freehold NJ 07728.

Sanitation Reminder

We hope everyone is already aware of this information, but just in case, here it is again:

There will no longer be trash collection on the following recognized municipal Holidays. Trash collection will resume on your next scheduled day following the holiday:

New Years Day, Martin Luther King Day, Presidents Day, Good Friday, Memorial Day, Independence Day, Labor Day, Veterans Day, Columbus Day, Thanksgiving Day, Friday after Thanksgiving and Christmas

The Borough Sanitation Department will only collect Bulk Refuse once each month, per recycling zone. Zone 1 [one] will have bulk pick-up on the FIRST Saturday of the month

and Zone 2 [two] will have bulk pick-up on the SECOND Saturday of the month. Bulk refuse cannot be brought down and dropped off at the Borough Yard.

There will be no other pick-ups for bulk items, so please plan your cleanups, moves and deliveries accordingly.

You can go to http://www.ahnj.com/ahnj/Announcements/Recycling to locate the Zone Map and see which zone you are in. You will also find information on what to do with other non trash/recyclable items.

Prior to placing any appliance item at curbside for collection, the owner, tenant or resident of the premises must obtain a permit from the Borough. The permit is obtained by

coming to Borough Hall, completing the appropriate paperwork and paying the required fee. Once the permit is obtained, an appointment will be scheduled for the removal of the appliance[s]. The permit MUST be affixed to the item to be removed by the Borough. The fee for obtaining a removal permit is fifteen (\$15.00) dollars per item. All items placed for collection have to be placed curbside no earlier than 6:00 p.m. on the day before the designated collection day and not later than 6:00 a.m. of the collection day. Before placing any refrigerator or freezer for collection, all doors must be fully removed. Refrigerators and freezers shall be placed for collection with the open side facing up.

Flu Shots Available

The Monmouth County Health Department is continuing its efforts to limit the effects of the 2012-2013 seasonal flu seasons by offering flu shots on Wednesday, October 03, 2012 from 1:30pm until 2:30pm at the Senior Center in the Atlantic Highlands Harbor.

Generally speaking, anyone over six months of age can receive the seasonal inactivated influenza vaccine. Influenza vaccine is recommended for anyone who lives with or cares for people at high risk for flu-related complications, including health care providers, household contacts and caregivers of children from birth to 5 years of age, and household contacts and caregivers of people 50 years and older or with medical conditions that put them at higher risk for severe complications from influenza. A yearly influenza vaccination should also be considered for people who provide essential community services and people living in dormitories or under other crowded conditions.

Individuals who should not receive the influenza vaccine are:

- · those with an allergy to eggs and egg proteins
- anyone with a previous life threatening reaction to a flu vaccine
- · individuals with a history of Guillain-Barre syndrome

Clinic participants will be screened by a registered nurse regarding risk factors and educated about the vaccine. A parent or guardian must sign a vaccine consent form for children six months to 18 years of age.

Residents of Municipalities serviced by The Monmouth County Health Department will pay \$20 for the seasonal influenza vaccine. Individuals who reside in non-member towns are also eligible to receive a flu shot, from the county Health Department, at a cost of \$30 for the seasonal influenza vaccine. As always, the vaccines are free to seniors with Medicare Part B. The county Health Department does not accept or bill insurance companies, but will provide a receipt suitable for submission to a health insurance company.

Residents living in the following towns are covered by the Monmouth County Health Department: Aberdeen, Allentown, Asbury Park, Atlantic Highlands, Avon, Belmar, Bradley Beach, Englishtown, Farmingdale, Hazlet, Howell, Lake Como, Manasquan, Marlboro, Matawan, Millstone, Neptune, Neptune City, Oceanport, Ocean Grove, Roosevelt and Union Beach.

Operation Reassurance

The Atlantic Highlands Police Department is reminding residents of Atlantic Highlands about a program that we offer, called "Operation Reassurance." This program allows a resident who lives by him or herself, the reassurance that their welfare will be checked daily. If a resident is interested in being a part of the program they can contact police headquarters for an application. Once the application is filled out, that resident will be put on our daily check list. Each morning between 7 a.m. and 10 a.m. each participant in the program will call headquarters to advise us that everything is fine that day. If a phone call is not received by 10am the police dispatcher will call the residence and check on the participant. If there is no answer, the dispatcher will send an officer to the house to check on the person's welfare.

Open Public Records Act

What is the Open Public Records Act (OPRA)?

OPRA is the State statute that replaces the old "Right to Know Law" which governs the public's access to government records in New Jersey. The law is compiled in the statutes as N.J.S.A. 47:1A-1 et seq.

Specifically, OPRA is intended to:

- ☐ Expand the public's right of access to government records;
- ☐ Create an administrative appeals process if access is denied; and
- ☐ Define what records are and are not "government records."

What is a "government record?"

OPRA specifically defines a government record as:

"...any paper, written or printed book, document, drawing, map, plan, photograph, microfilm, data processed or image processed document, information stored or maintained electronically or by sound-recording or in a similar device, or any copy thereof, that has been made, maintained or kept on file ... or that has been received in the course of his or its official business ..."

OPRA provides that the custodian of government records in a municipality is the municipal clerk. However, OPRA does not preclude a municipality from developing reasonable and practical measures for responding to OPRA requests, which may include the designation of deputy custodians for particular types of records (most common occurrence is the Police Department).

When should I expect a response to my OPRA request?

Custodians should fulfill a request as soon as possible but not later than seven (7) business days after the request is received, provided that the record is currently available and not in storage or archived. Day One (1) is the day following the custodian's receipt of the request. Verbal responses, even if within the statutorily mandated seven (7) business days, are not valid responses under OPRA.

What is a broad and/or unclear request?

If a request does not name specifically identifiable records or is overly broad, a custodian may deny access. Example of an overly broad request: "Any and all records related to the construction of the new high school." The term "records" does not reasonably identify a specific government record. A custodian is obligated to search the files to find the identifiable government records listed in the OPRA request, however a custodian is not required to research files to figure out which records, if any, might be responsive to a broad and unclear OPRA request.

Drivers **MUST** STOP for pedestrians

New Jersey Statute 39:4-36

It's the law!

- 1. According to the National Highway Traffic Safety Administration (2006), New Jersey is 7th in the country for pedestrian fatalities.
- Each year, an average of 150 pedestrians are killed and another 5,875 are injured in New Jersey due to auto related crashes.

In New Jersey, the law is clear...

- Drivers must STOP for pedestrians crossing within crosswalks.
- Pavement markings are not required for crosswalks at intersections.
- Drivers may not overtake or pass another vehicle that has stopped for a pedestrian to cross.
- Turning vehicles must stop for pedestrians crossing during the WALK signal.
- No pedestrian shall suddenly leave a curb or other place of safety and walk or run into the path
 of a vehicle which is so close that it is impossible for the driver to stop.
- Every pedestrian upon a roadway at any point other than within a marked crosswalk or within an unmarked crosswalk at an intersection, shall yield the right of way to all vehicles upon the roadway.
- Drivers failing to STOP 2 Points, \$200 fine (plus court costs), 15 days community service, and/or insurance surcharges
- Pedestrians failing to comply (C.39:4-32 and 33) \$54 fine




Farewell Salute to Chief Mazzarella

Retired Chief Charles Mazzarella, age 61, passed away Saturday, July 28, 2012 peacefully at home. Born in Manhattan, where he lived, before moving to Atlantic Highlands many years ago. Charlie was the past Police Chief of Atlantic Highlands, proudly serving as the youngest police chief in the department's history. He was hired by the

Borough of Atlantic Highlands on August 27, 1972 as a patrolman. In August of 1979 he obtained the rank of Detective and in March of 1980, Detective Sergeant. He was promoted to Captain in July of 1986 and then promoted as Chief in May of 1987. He remained Chief for 13 years when he retired on August 31, 2000. Charlie was a past member of the Monmouth County, New Jersey State and International Chiefs of Police Associations and was proudly affiliated with the National Center for Missing and Exploited Children.

Winter is Coming!

This a reminder that the owner of every lot, tract or parcel of land fronting on any street, highway or public place within the Borough of Atlantic Highlands shall, within 24 hours after the termination of a precipitation event causing the sidewalk, to be covered with snow or ice, remove, or cause to be removed, such snow or ice. Ice which is so frozen as to make removal impractical shall either be treated with rock salt or other chemicals which will thaw it sufficiently to permit removal or be thoroughly covered with sand. Failure to do so will be violation of the Borough Code and could subject you summons.

Please also be aware that shoveling snow into the street after snow plows have come by is counterproductive and dangerous as it freezes and causes clumping in the traffic path.

It would be extremely helpful if during snow events residents move as many cars off of the street as possible. The presence of cars does not allow the snow plow to plow the road curb to curb, leaving snow mounds in the street. Once your car is removed and if the plow comes down the street again, there is a possibility that you may return and find your driveway clogged again with the cleared snow. Removing cars from the street will help prevent that. Parking cars on frozen lawns, in neighbor's driveways or even public parking lots should be considered. Even coordinating with your neighbors to have everyone park on one side of the street and after the plow clears the one side, everyone move their

cars to the cleared side until the plow comes again and cleans the other side.

Also remember to clean your cars before you hit the streets. In 2009, Gov. Jon Corzine signed a bill that would allow law enforcement officers to ticket motorists with dangerous amounts of snow or ice accumulated on their cars. This law is aimed at preventing ice and snow from flying off fast-moving vehicles and hitting other cars.


The officials here in Atlantic Highlands aren't out to fine residents, but instead want them to understand the need for swift, efficient removal of snow and ice for the safety of the public.

About Foreclosure — First Steps

Accurate information and a plan of action is KEY for homeowners either currently going through or facing potential foreclosure. The State of New Jersey and the Federal Government provide a variety of programs to assist homeowners. Information about these programs is FREE.

Here's all the necessary info you'll need to get started.

If you are in Foreclosure:

- Contact the Office of the Courts
 Foreclosure Mediation Hotline
 at 888-989-5277 or visit www.
 njforeclosuremediation.org. This
 Foreclosure Mediation Program
 provides homeowners who are
 in foreclosure with access to
 housing counselors and court
 trained mediators to resolve
 foreclosure actions. A mediator
 and counselor will work with
 you and your lender to work
 out your mortgage so that
 your future payments will be
 affordable to you.
- Review the Federal and State Mortgage Modification Programs available to you. There is NO FEE to get information about these programs.

If you are not in Foreclosure:

 If you have missed a payment or payments or feel that you will soon miss a payment because your mortgage is no longer affordable to you, you should call your mortgage servicer.
 The number should be on your monthly mortgage bill or coupon book.

- You may also contact a housing counseling agency in the county in which you live. See pages 3 and 4 of the Foreclosure Fast Facts (1.7MB PDF) (Spanish version) (2.2MB PDF) sheet for a list of counseling agencies. The counseling agencies listed here are non-profit, HUD certified and trained in foreclosure prevention.
- Call Today, Do Not Delay! The sooner you call the more options you will have.

Beware of Foreclosure Rescue Scams - Help is FREE!

- There is never a fee to get assistance to work out your mortgage or to get information about the programs listed here from your lender or a HUD certified housing counselor.
- Beware of any person or organization that asks you to pay a fee in exchange for housing counseling services or modification of a delinquent loan. Do not pay – walk away!
- Beware of anyone who says they
 can "save" your home if you
 sign or transfer over the deed
 to your house. Do not sign over
 the deed to your property to
 any organization or individual
 unless you are working directly
 with your mortgage company to
 forgive your debt.

- Never submit your mortgage payments to anyone other than your mortgage company without their approval.
- If in doubt do not pay and walk away.


If You Feel You Have Been the Victim of Mortgage-Related Fraud

Containerized Yard Waste

Borough Ordinance #03-2011

Yard Waste Collection

Sweeping, raking, blowing otherwise placing yard waste at the curb or along the street is only allowed during the five (5) days prior to a scheduled and announced collection, and shall not be placed closer than 10 feet from any storm drain inlet. Placement of such yard waste at the curb or along the street at any other time or in any other manner is a violation of this ordinance. If such placement of yard waste occurs, the party responsible for placement of the yard waste must remove the yard waste from the street or said party shall be deemed in violation of this ordinance.

Borough Yard Open

The Borough Yard will be open SUNDAYS FROM 9:00 AM TO 12:00 NOON, beginning November 18th thru December 16th, so residents may drop off leaves and brush.

NO OTHER MATERIALS WILL BE ACCEPTED!

A current New Jersey's driver's license, with a valid Borough of Atlantic Highlands street address must be presented for access to the yard.

Landscaping companies, residents of surrounding neighborhoods, or PO boxes with 07716 zip codes will not be permitted to enter the yard

Brush and leaves will be picked up during this period ONLY. *Please make sure all leaves and brush are put at the curb, ready for pick up, BY THE FIRST PICK-UP DAY FOR YOUR ZONE. If brush/leaves are not placed out prior to your streets pick up and you miss your zone's pick up, you may not put brush/leaves out until 5 days prior to your next scheduled pick-up. And the yard waste put out must be removed or you shall be deemed in violation of Borough the Code. Please do not mix grass clippings in with any brush or leaves. Please do not bag your leaves [except residents along Memorial Pkwy].

I have been very blessed! I have had the extreme pleasure of being part of your lives, and your children's lives, in a very special way for nearly 20 years. I have been able to meet with you, and talk books and movies with you, and help you find your own magic carpet to places of your choosing.

At the end of last year, a newcomer, obviously of foreign extraction, came into our library for the first time and gestured to the surroundings. (This was at the Field house, mind you.) She said, "You are so lucky to be here! All this!!! So many wonderful things!" She was RIGHT!

What an opportunity to work -surrounded by so many items that give nourishment and enjoyment to so many!! From first board book, to SAT prep; from Ali Baba to Harry Potter! From Justin Beiber to Albert Einstein! From artists to 'The Artist'.

The library was a special place for me in which to work, but not just for the materials which surrounded me; it was the people!!! People who use the libraries are eager to venture beyond where they are! 11-year-old Rodrigo (name changed) came into the library as part of a class field

trip. He and his family had just arrived in this country, and he could barely speak English. As I was giving a little tour of the library to his class, I wasn't sure if he understood anything that I was saying. But, then immediately after school, there were he and 3 his brothers, all wanting to get library cards!!They have been enthusiastic users of the library ever since - and speak English very well. Rodrigo and his family were ready to take part in a journey, and as a Librarian, I could help them along. What joy!

And what sharing! I think that Librarians, at least the ones here. might be on a par with bartenders and hairdressers. Many a reference question was often a patron's jumping off point for a more serious discussion: "Do you have a book on breast cancer?" "What kind of information do you have on bankruptcy?...wedding planning?... adoption?...divorce?...Alzheimers?"... was often the way the conversation would begin. And then the personal stories would come pouring out.

My work here was never a solo operation. Any job accomplished was ALWAYS because of those around

me. Barbara Nelson, former director, was my mentor. Our staff: Melody King, Phyllis LaMarche, Jane Reynolds (our new Branch Manager), Faye Sacco, and Patrick Lynch, were always by my side, doing an outstanding job. The Library Board, with Bob Schoeffling as President and George Wuesthoff as treasurer, was always supportive, and provided much of the money needed for shelving at our new Library. The Friends, under the talented leadership of Linda Lucas, provided programs and support. So did the Masons. My husband, Mike, who did much of the publicity for the library, was always there to pitch in whenever I asked him - and I asked him a lot. Adam Hubeny, my former boss, spearheaded the library project, and you, the mayor and council, who saw its immense value, made possible the fabulous library we now have. I can't thank you all enough!
