

We are submitting this letter on behalf of the Owner/Applicant in for the above referenced property to the Atlantic Highlands Borough Planning Board. Generally, the application in question has been revised as follows:

- Revision to the parking layout to relocate the Electric Vehicle charging stalls out from under the building. ADA stalls have been revised and an accessible route across the lot provided;
- The sight triangle along East Garfield has been revised. One parking stall has been eliminated from the plan to avoid sight conflict;
- Tree locations, species, size and condition have been added to the survey;
- Proposed landscaping has been revised per the Shade Tree Commission comments;
- The sidewalk in front of the refuse enclosure has been revised to direct pedestrian traffic away from the stop bar. The stop sign has been relocated to an area between the trash enclosure and egress.
